MALAWI MIGRATION PROFILE

A Migration Profile is an evidence-based approach that assess the migration situation in a country. It provides a comprehensive analysis of current trends, patterns and changes in migration related sectors.

Following Malawi's membership to IOM in 2013, the compilation of a reliable evidence base that would inform such a policy emerged as a priority.

The product brings together existing information from different sources in a structured manner and provides a comprehensive overview of key interna-

migration and socio-economic development trends in Malawi. Furthermore it also identifies data gaps and potential strategies to improve data collection for policy and planning purposes.

The Malawi Migration Profile was a collaborative effort between IOM and a wide range of government ministries, departments and agencies, in bringing together data on migration that was captured by various actors but remained scattered for use in policymaking.

IOM is launching Malawi's first ever Migration Profile which is primarily driven by the Government of Malawi's desire to develop a comprehensive national migration policy that would address the complex migration dynamics Malawi faces as a country of origin, transit and destination.












CAMP COORDINATION CAMP MANAGEMENT

IOM Malawi, in cooperation with the Department of Disaster Management Affairs (DoDMA) and with financial support from USAID's Office of Foreign Disaster Assistance, launched a project on Camp Coordination Camp Management (CCCM) & Disaster Risk Management (DRM) for Malawi in January 2015.

The aim of the project, is to strengthen the national capacity of key DRM stakeholders to effectively protect and assist displaced and



Through this project, IOM intends to improve national human and technical capacity in Malawi to mitigate the impact of natural disasters. In response to the floods that left 230,000 people displaced,

IOM supported humanitarian actors in the management of camps using the CCCM programme.



Activities

Disaster Risk Management

CISONECC influenced the development of the national Disaster Risk Management Policy by mobilising and consolidating civil society's voice as well as engaging government to provide inputs into the policy.

Climate change policy

Through a similar process, CISONECC participated in the development of national climate change policy for Malawi by providing inputs at all stages of the policy development process including consulting communities to ensure that proposed policy elements reflect community interests.

Influencing government's preferred positions to international negotiations

CISONECC has been working closely with government by providing inputs into Government of Malawi's preferred positions to Conferences of Parties (COPs) to the United Nations Framework Convention on Climate Change (UNFCCC). In doing so, CISONECC makes use of evidence from the interactions of member organisations with local communities to ensure that final positions reflect local perspectives.

Influencing inclusive and responsive adaptation planning and implementation In May, 2013 CISONECC prioritised advocacy for inclusive adaptation planning to ensure that priorities in national frameworks such as the National Adaptation Programmes of Action and the National Adaptation Plan respond to community needs.

Information sharing

CISONECC facilitates awareness and knowledge sharing on integrating climate change in development planning and implementation at all levels through radio programmes and publications.

Established in 2007 on World Environment Day, the Civil Society Network on Climate Change (CISONECC) is an umbrella platform for coordinating civil society response to climate change in Malawi. The young coalition is a dynamic network created to coordinate the development sector's climate change efforts for more impact on government policy processes.

The Network is duly registered as a trust and has a board of Trustees.

Membership

CISONECC is made up of 33 local and international non-government organizations as well as networks and associations working in climate change and Disaster Risk Management (DRM).

Vision

Building resilient communities and ecosystems to the impacts of climate change

Mission

To provide a platform for engagement between government and CSOs on climate change and related fields for improved adaptation and mitigation to climate change impacts

Strategic Objectives

The network is guided by a Strategic plan with the following strategic objectives:

- Policy research and advocacy
- Capacity building and information management
- Fundraising and resource mobilization
- Networking, coordination and collaboration
