Iam a county project director and Founder of Africa Child Foundation Mission of Tanzania, My special professional is a teacher and inspector of teaching and learning for young children at School, Iam inspecting project implementation from the stage of selecting area up to the end , Also I have attended Diploma in School quality assures Inspector from ADEM – Bagamoyo where we studied Project Monitoring and Evaluation, IT, Research development, Project proposal write up.

LEGAL REGISTRATION

Africa Child Foundation Mission of Tanzania (ACFMT) established since early 2017 and registered in the year 2021 Under NGO Act No. 24 of 2002 of Tanzanian Laws which amended in 2005 and 2019. It has been registered at The Ministry of Health, Community Development, Elders and Children. It awarded a Certificate of Registration at National level with Registration Number 00NGO/R/2384 of 7th October, 2021.

TRAINING EXPERIENCE

I have attended training in short courses which deal with Women law, regulations and policy in Tanzania. Those courses are: in Preventing of Sexual abuse for Women and Girls, Toxic instrument for Women at home in the community, Human Rights, Women development skills. The organizer of training was East Africa Human Rights Institute, Tanzania Human Rights defenders, Haki Elimu Tanzania, Aidonic Ag and Aramaic Relief for one week. Draft for preparation of VISION 2050, for being ready submitting to government October, 2025 and policy making.

Our objective is to deal with Women and girls at different aspects like farming area, mines area and night club bar where Women and girls are engaged to dangerous activities. Our mission aligns with our organizations name because we stand before Women, girls who are mother of child all the time, when we help women and girls it means that automatically we help child because all child depend on their mothers for getting food and love, so we are avoiding abuse at any area of difficult especially to the Women and girls. Every difficult we discover, here, listen, see we are helping them in collaboration with Community Women and girls safe security and peace life. we insist every time to enforce government in implementing Women and girls rights laws, Policy, International Charter and regulations for enabling them to get their important rights like education, health, food, shelter, Security and love from community, parents, school, home and other places where Women and Children are staying.

Not only that but Also we are building capacity to the ward and village government stakeholders for making sure that Women and girls are safe all the time and any case which tackle the children our organization are ready to solve it and make the children free from dangerous.

All organs are enable our organization to know well the rule, regulations of Child rights in Tanzania and climate impact to the community. Through that organization our organization has conducted more than 25 forums for discussing the rights of

children including Child labour in Mining and other different business at Morogoro Region, Mbeya region, Mwanza regions, Dar es salaam regions. Those events was deal with explaining the rights and regulation of following for helping children

Also we are the member of Tanzania Independent election (INEC) as supervisor and voters educators for two region which are Tanga and Morogoro.

Africa child foundation mission of Tanzania is governed by the board of directors comprising 9 members and the management run by the employed staff lead by the Country Project Director. Other staff include trainers, office secretary/cashier and office messenger/guard and volunteers are the total number of 356 all the country.

ACFMT is funded by two donors which are ARAMAIC INTERNATIONAL RELIEF FROM SWITZERLAND and AIDONIC Ag. Under Severiyos Aydin. However, ACFMT can access funds from other donors both local and international because we have already registered into SAM.Gov for **Unique Entity ID** which are YLQBRLH3DMA1, **EIN number** are 84-4898082 and **NCAGE CODE** is SRRV5, which enable us to apply fund through work space account.

Previously We have done the project at Kibaoni village ,Mvomero District Morogoro region , during the project implementation it has shown that the children soround mines area 26% are not finishing their studies they go to mining areas and continue finding money for their life instead of continuing with education, but in our training at 5 primary school which are Kibaoni melela, Doma, Mgeta and Langali we have seen that the main contributing factor to child labour in at that project was found to be the low family income or extreme poverty. Thus the use of low paid labour or unpaid in at that area has been the necessary condition for the survival of the majority of both artisans and medium-scale diggers. The maintenance of quasifeudal dependency relationships between claim holders and children explains the serious exploitation of child laborers, as they are not normally paid at the same rate as adults doing the same work also many children are stopping their studies due to gathering livestock, Prostitution business to young girls who are leaving from their village and going to Morogoro town and other place like Dar es salaam, Dodoma and Mbeya city for sexual busness to lodge and Night clubs which cause them to stop their studies and most of them being affected by HIV and finally die.

During our training we have trained Different charters and regulations which are Child Protection Regulation Tanzania, 2015. Cap 13, Kanuni za makao ya watoto Tanzania, 2012, Sura 13, Kanuni za malezi ya kambo Tanzania- 2012, Sura 13, Kanuni za uasili wa watoto Tanzania- 2012, Sura 13, Kanuni za usalama wa mtoto Tanzania-2014, Sura 13, The law of Child Act revised 30/11/2024/Section 4 of Laws, Revision Act, Chapter 4, Tanzania forestercare- placement

regulations-2012, The Juvenile court rules of 2016, Challenges Affecting HRD of Children in Tanzania-2014, Children right situation in Tanzania(TCRF), 2012.

Funders who help us are , Aramaic Relief international who supported us USD 35,000 , for the programme of child rights training and school food feeding at Kibaoni primary school as the characteristics of helping poor children to attend at school every day instead of staying at school with empty stomach .

The other programme supported by Aidonic Ag and Aramaic Relief are child rights documentary in factors affecting girls and poor families in coming to school while they are staying far from school , for example student of Kibaoni primary school are working 24 km per day from home to school and using 4 hrs to walk where by at the forest passing she is facing with elephant and other dangerous animals which cause them to fail to complete their studies and fail their examination. On that we have documentary to the platform of Adonic, Search with. Improving school feeding nutrition from Tanzania, sponsored by Aidonic and done by Africa Child Foundation Mission of Tanzania.

Our organization continue partnering with Human rights Defenders from Tanzania and are those who will implement the project of Child Labour in Mining at Chunya district for 12 ward selected where by the most activity will be capacity building for the community of Chunya to understand the Regulation, Law and policy which guiding children in Tanzania and enforce the community to use their learned law and policy in protecting children through child labour in Mining.

Second activities will be Capacity building to stakeholders from Mining, Government , Education sectors , Political readers, Religion readers, Security Police sector and Community development to got training on how they can use the policy, Law and Regulation of defending the children to enable the community to understand the impact of using young children in different business like mining, Agriculture, Gathering animals, Prostitution business and stop continuing with their studies which distract the life of children and finally we will get poor children who will be lobbors, drug users, cause conflict to the community and finally cause war because the end of using drug is to engage in bad activities.

Third the Project at Chunya will deal with establishing 80 working group of women which will be with 50 women each group, and each group will have chairman, secretary, Teacher and Mining member who working from mining. on that they will establish banking group by starting with USD\$1000 for each group where by every group will use that seed to start getting loan and engage in entrepreneurship where by each one will be able to start with getting USD \$30 , per starting and will enable them to get profit. At that group also they will continue learning the impact of engaging

young children at Child labour in Mining which cause the young children to be affected healthy and most of them are died due to dust found to the minerals and hardworking they are doing with small payment , therefore those leaders of working group will supervisor the children to their area and they will continue providing report every 3 months from their community if the is improvement of the end children to Child labour to the mining area and the report will be sent to the sponsor of the project and government of Tanzania .

Fourth activities will be provision of School learning material to poor children who are found at 12 wards where children are engaging in mining job. For that area poor children will be helped in school books, School uniform and food for those who will be seen there are at mining area while they were suppose to be at school, also those who stopped secondary school for two years past the project will include them in giving them support to return at school for all boys and girls, even girls if they were received pregnant while they were at mining area also they will be returned to school for continuing with their learning.

Fifth activities will be training on how to use mercury, on that are the partner from United states of America and sponsor of the project will train the community in mines area on how to use mercury or to use other method instead of mercury, on that training and conferences will be conducted at 12 ward for 6 days each training which will enable the community to know the impact of using mercury.

Finally will be Monitoring and Evaluation, at that stage the auditor will be employed and auditor the pre stage before starting the project and to the end of the project, so for two orditing will show us our improvement of the programme and how we have reached for our implementation. Also partners from United States of America are allowed to follow up the implementation of the project internally and we are ready for any area to partner with them.
