- 2) Tmt. Bernadth, aged about 40 years, Wife of S.R. Thomas, residing at 10, Ramsait Nagar, Vellore Town, Vellore District.
- 3) Tmt. Chandra Manickam, aged about 45, wife of Manickam, residing at 15, Servai Mimsamy Street, Velapadi, Vellore Town, Vellore Dt.,
- 4) Mrs. D. Rita, W/o. R. Sugunanandhan, aged about 48, No. 8 Sundarat st., Thirunagar, Vellore-6.

Whereas we the above named are desirous of forming, constituting and establishing a Trust under the name and style "GIRLS RAMBIFICATION EDUCATION ASSOCIATION TRUST" for the promotion of education, Technical Education, Socio-Economic Upliftment, Community development, child development, Health development, and for the purpose of carrying out the objects herein detailed.

We, the founders of the trust, herein, have decided and agreed amongst ourselves that we shall constitute the first Board of Trustees herein after referred to as trustees, The number of Trustees can be increased to maximum of Nine.

Mr. S.R. Thomas is the author of the Trust and has set apart and contributed initially a sum of Rs. 500/- (Rupees five hundred only) only in trust to be held as CORPUS for carrying out the purposed and objects set forth in this Deed.

1) At present there is no immovable property belonging to the Trust. The trust fund shall be the initial contribution of Rs.500/- (Rupees five hundred only) set apart as here in before mentioned and other contribution and donations that the trustees may hereafter receive either being kept as CORPUS or being dealt with by them for being expended for the various objects and proposes of the Trust herein after mentioned

2) The trustees do hereby acknowledge that the trust stands possessed of the sum of Rs.500/- (Rupees five hundred only) given by the author.

3) The objects of the Trust shall be all or any of the following:-

a) "GIRLS RAMIFICATION EDUCATION TRUST" (GREAT) is a non political non religious, non profit non sectarian, chartiable and voluntary social service centre.

b) To impart useful and educative information in all matters affecting social economical cultural and scientific life to the public in general and particularly to the ignorant people of undeveloped remote villages, urban, town and to youngsters to make them better citizens.

c) To start and run, maintain, manage, administrate Industrial training Institutes, Industrial training centre, Polytechniques, schools, High schools, Colleges Diploma courses, N.C.V.T. and S.C.V.T. approved Training/centres/Institutes, Degree/Diplamo courses etc., any where in Inida.

f) To promote health programmes, and teach and propagate preventive health care, health education, family planning, immunisation programme etc.,

g) To start and maintain hospitals, medical Non Medical colleges medical diplamo courses, Nurse training colleges, and other medical Technical Training courses etc.,

i) To promote womens Education, The service of the Trust shall be Extended to all people irrespective of caste, religion and sex.

j) To conduct environment programmes.

k) To conduct Aids Awareness programmes, To start Aids counselling centres, To spread the dangerous of HIV/AIDS (through meetings, posters, Drammas, Medias Etc.,)

l) To open handicraft centres for boys and girls and to teach them useful handicrafts like carpentry, Typewriting, Tailoring, Basket making, computer training, cotton, and silk weaving, and small cottage industries such as mat weaving paper making etc.,

To Open and maintain short term Technical and non Technical courses and Trainings.

- m) To conduct Childrens programmes and eradicate child labour.
- n) To start vocational training centres for women and men and to start nursery schools for childrens.
- o) To start prevention of Drugabuse centres.
- p) To start maintain, and manage formal or Non formal schools, colleges, Evenings and Day colleges, Training schools.
- q) In collaberation with government and other agencies.
- r) To open orphanages and hostels.
- s) To start Adult Education and non formal education and run high schools for the benefit or illiterate adults.

to seek the financial help by all means and sources and also to seek foreign aid for the betterment and maintenance of the educational industrial institutions orphanages and hostels, hospitals run by the Trust No funds/profits/Income shall be distributed to members/Trustees in any form such as Dividend, interest etc.,
2) To do all such other things as are incidental and conducive to the achievement of the above objects or any of them.

MANAGEMENT

4) The number of Trustees in the Board of Trustees shall not be less than three Additional trustees may be co-opted for specific periods by the Board of Trustees.

5) Thiru.S.R.Thomas, the author of the Trust, shall be the chairperson of the Board of Trustees and hold office till his life time (or) till her resigns, other Trustees shall hold office for a period of Five years from the date of formation of the Trust and they will retire after the expiry of the period of five years and they will be eligible for re-election after retirement.

5)(a) Tmt. Bernadth, shall be the "Financial Trustee", She shall hold the office for 5 years However she shall hold the office as in the capacity of "Trustee" for her life times. He can be re-elected after five years by General Meeting of the Trustees.

b) If any time, any trustee resigns or dies the vacancy shall be filled by the existing trustees as per the decision of majority of trustees, However such ex-trustee also eligible for Re-appointment.

c) If any trustee does anything against the general interest/ General object of the Trust such trustee can be expelled from board of Trust, such person shall not have any right in the Trust/trust property.

d) If the trustee does not attend the consecutive 3 meetings, he/she shall be expelled from the board of Trust.

6) The Board of Trustees shall meet at least once in sixmonths to transact business.

7) Proper books and accounts regarding the moneys, received investments made, expenditure incurred etc., as well as of the properties both movable and immovable assets, securities documents and liabilities etc., of the trust shall be maintained properly.

OFFICE

The Regd. office of the Trust is at present located at 10, Ramsait Nagar, Thorapadi, Vellore Town, Vellore Dt., Tamilnadu, The office premises may be changed to suit the conveniences of the trust and as per the majority decision of the Trustees, The Branch or Branches may be opened in any where in India.

FUNDS

9) The Trustees will open one or more accounts with schedule banks and Nationalised Banks, all transactions shall be operated by the chairperson, The funds shall be Invested as per the provision Section 11, 12, of Income Tax act, 1961 and its later amendments.

10) The accounts of the Trust shall be audited once in a year by an author appointed by the Board of Trustees whose report shall be considered by the Board of Trustees to rectify all matters, The Trust in non-revocable.

12) In case of dissolution of the Trust for not being able to function all the movable and immovable properties belonging to the trust shall be handed over to any other Trust or Institutions having the same object(or)objects similar to those of this Trust at the majority decision of the then trustees of the Board of Trustees.
