#### **REVIEW OF PROGRESS & RESULTS:**

The General Body Meeting of SST held on April 15, 2017, reviewed the progress & results and approved the annual activity report for the year 2016-17. The following are the activities under taken and progress/results achieved during the year. We have conducted the following programs with kind support of our EC members as well as local service motive persons and philanthropists. We obtained financial assistance from Reserve Bank of India, Mumbai; National Commission for Women, New Delhi; OTF, Canada; SYA/CTFK, USA; Shamdasani Foundation, Hong Kong; Air Tel; Tata Docommo; TRAI; BSNL; Telenor etc.

- 1. DISTRIBUTION OF BEDDING MATERIAL AND COSMETICES TO ORPHAN STUDENTS: We have conducted the Distribution of Bedding Material and Cosmetics to Orphan students on 24/04/2016 at Joy Home Orphanage, Kurnool, Kurnool Mandal, Kurnool District, Andhra Pradesh. The Beneficiaries were 40 Orphans students. The Guests Participated In the Program were Ms.Malleswari, President, SST NGO; Mr.V.Anjaneyulu, Director-SST NGO; Mr.A.V.Ramanaiah, State Resource Person; Mr.A.Madhu Babu, Advocate; Mr. T.Ramakrishna, District President, A.P. Journalist Forum; Mr.Akhil, Coordinator, Joy Home Orphanage; Mr.Ashok Kumar, Manager, SST NGO. The Material Distributed was Bedding Material like Blankets, Bed sheets, Towels, Napkins and Cosmetics like Washing Soaps, Bathing Soaps, Hair Oil, Face Powder, Tooth Brushes, Tooth Paste. Shamdasani Foundation, Hong Kong supported for this program.
- 2. DISTRIBUTION OF EDUCATIONAL MATERIAL TO ORPHAN STUDENTS: Distribution of Educational Material to Orphan students was conducted on 24/04/2016 at Joy Home Orphanage, Kurnool, Kurnool Mandal, Kurnool District, Andhra Pradesh. The Beneficiaries were 40 Orphans students. Pencils, Sharpeners, Dictionaries, General Knowledge Books, English Grammar Books etc. OTF, Canada supported for this program.
- 3. EDUCATE WOMEN & GIRLS ON THEIR RIGHTS & ENTITLEMENTS: We have organized the program on "Educate women and girls on their rights and entitlements: on 25/04/2016 at Community hall, Sudireddypalli Village, Kurnool, Andhra Pradesh. The speakers participated were Mr.V.Anjaneyulu, Director-SST NGO; Mr.A.V.Ramanaiah, State Resource Person; Mr.A.Madhu Babu, Advocate; Mr. T.Ramakrishna, District President, A.P. Journalist Forum; Ms.Jaya Lakshmi, Asst. Instructor; M.Byagya Lakshmi, Instructor, Tailoring & Embroidery. We educated women and girls on their rights and entitlements like human rights, women rights, government schemes, loans, ration cards, house pattas, subsidies, incentives, etc. 50 women and girls participated in the meeting. They will utilize the government schemes properly, understood their rights and empower socially, economically, and culturally.
- 4. DEPOSITOR EDUCATION AND AWARENESS WORKSHOPS: We have conducted Depositor Education and Awareness Workshops in collaboration with Reserve bank of India, Mumbai from 04/06/2016 to 30/06/2016 at Five locations namely Kurnool, Dhone, Kodumur, Kallur & Veldurthy Mandals of Kurnool District, Andhra Pradesh. We educated and spread awareness among the excluded sections of the society about benefits of financial literacy, information about various financial products available on various channels explaining the procedure / formalities, RBI Guidelines on KYC, Opening of Accounts, Loans, Deposits, Jandhan accounts, Financial transactions, Social security insurance schemes, RBI Initiatives on Consumer protection, Banking Ombudsman, Charter of Consumer Rights, Customer Rights Policy, Complaint Redressal Mechanisms

- etc. 44 guests and resource persons like AGM of RBI-Hyd. & NABARD, Regional Managers & Branch Managers of APGB, SBI, AB, KDCCB, Project Director-MEPMA, Mandal Development Officer, Mandal Tehsildar, Mandal Education Officer, Inspector of Police, APMs of DRDA, Senior Counsellor, Finance Literacy Centre, Advocates, NGO Leaders, Trainers & Resource Persons to NGOs on Finance Literacy & Capacity Building etc. have attended the workshops. 260 participants like SHGs Women, Social Workers/NGOs, Youth Volunteers, Businessmen/Farmers etc. benefitted from the program.
- 5. YOUTH LED COALITION BUILDING TO PROMOTE EDUCATIONAL & ADVOCACY CAMPAIGNS FOR TOBACCO CONTROL: The project "Youth-Led Coalition Building to Promote Educational & Advocacy Campaigns for Tobacco Control (APYATC) is being implementing in Kurnool District by Society for Social Transformation in collaboration with Star Youth Association CTFK, USA. We have communicated, contacted and coordinated with Nehru Yuvak Kendra, Degree Colleges & Youth Associations and Identified 28 youth leaders during 2<sup>nd</sup> week of March, 2017, in accordance with the guidelines on the characteristics of youth leaders communicated by SYA. We have convened Orientation Meeting on 22/03/2017 with all the 28 identified youth leaders. We explained them on ill effects of Tobacco use, need of Tobacco control, purpose of the project, characteristics of youth leaders, roles & responsibilities of the youth leaders in the project deliveries etc. Finally, selected 11 interested and eligible youth leaders and formed the Kurnool District Youth Advocacy action Group. Mr.V.Anjaneyulu, Director, SST NGO, Kurnool; Mr.Rayapati Srinivas, President, Nyice NGO, Kurnool; Mr.A.V.Ramanaiah, President, DINAKAR NGO, Kurnool; Mr.A.Madhu Babu, President, SRES NGO, Kurnool etc. briefed on the Tobacco control.
- 6. SEMINAR ON "ISSUES RELATED TO SINGLE WOMEN AND WOMEN IN DIFFICULT CIRCUMSTANCES: We have conducted the said seminar on 24th September, 2016 At Conference Hall, Hotel Suraj Grand, Kurnool, Andhra Pradesh. Ms. Sreedevi, Deputy Director, District Industries Centre, Kurnool; Mr.M.A.Hafeez Khan, Secretary, Hafeez Khan Memorial Foundation, Kurnool; Mr.V.Anjaneyulu, Director, SST NGO; Mr.T.Madduleti, NEA NGO, Kurnool; Mr.A.V.Ramanaiah, DINAKAR NGO; Mr. Vadala Prasad, Advocate & Member of District legal Service Authority, Kurnool; Ms.M.Suvarna, Extension Officer, District Women & Child Agency, Kurnool; Ms. E.Narmaada, Social Counselor, District Women & Child Agency, Kurnool; Ms. Faizunnisa, SFTTC NGO; and others participated in the seminar as guests and speakers. Inaugural session with Guests: They motivated and encouraged single women. They guaranteed their support and help in case of need. Created confidence among single women. The resource persons explained various provisions/facilities available to single women, discussed on various issues being faced by single women and suggested action points to be taken for the welfare of single women. Single women shared their life experiences, issues, and concerns. Ms. Gouru Chatitha Reddy, Member of Legislative Assembly (MLA), Panyam Constituency, Kurnool District participated in the valedictory and distributed certificates and mementoes.
- 7. HIV/AIDS AWARENESS PROGRAM: We have conducted HIV/AIDS Awareness Programs in 6 locations namely Kurnool, Kallur, Veldurthy, Dhone, Peapully and Kodumur. We have created Scientific Awareness on HIV/AIDS Consequences, Treatment, Prevention & Control among Youth and Women. Expert resource persons from health, paramedical, social service organizations participated in the program. We have educated the participants on Safe Sex, STDs, Personal Hygiene, Reproductive Health etc. Provided Information on HIV Testing Centers and encouraged them to have voluntary HIV Testing. We also Distributed Information, Education & Communication Material like Pamphlets, Posters and Brochures on HIV/AIDS Consequences, Treatment, Prevention & Control. We have conducted Rallies on 1st December, 2016 on the occasion of AIDS Day.

**8. TELECOM CONSUMER EDUCATION PROGRAMS:** As a Consumer Advocacy Group of TRAI, We have conducted the following consumer education activities: TRAI, BSNL, Telenor, Air Tel, Tata Docommo supported for this program.

We also conducted 2 consumer rights awareness camps at Kurnool & Kallur. 125 participants like SHGs women, Youth, Farmers etc. participated in the camps. We educated on various rights of consumers, consumer redressal mechanism, consumer forums etc.

- **9. WORKSHOP ON CLIMATE CHANGE:** There is inadequate awareness on adaptation and mitigation of climate change among general public particularly of women and farmers. Due to lack of awareness on climate change, the poor tend to deprive their livelihoods and suffer more with bad effects of climate change. Hence, we have conducted awareness camps on adaptation and mitigation of climate change among women and farmers at V.Belegal & Gudur Mandals. This program Increased awareness on adaptation and mitigation of climate change among women, youth, farmers, general public etc. 50 participants benefitted from this program which leads towards a low-carbon, climate resilient economy. About 120 people benefitted from this program.
- 10. SKILL TRAININGS IN COMPUTERS & TAILORING: We have provided Computer skills trainings for a period of three months to 25 youth. This program will address the dearth of Computer skill inputs being experienced by several youth particularly of marginalized in Kurnool Mandal of Kurnool district of Andhra Pradesh. We have sponsored the selected 25 youth to Nice Computer training for providing training in computers. We also provided Tailoring Training to 30 women & girls for a period of 3 months. We trained them in cutting, stitching, embroidery etc. We sensitized them on savings, bank loans, government subsidies & incentives. The trained people will get employment in government/private sectors or start self-employment units of their own, thus empower educationally, socially and economically.
- 11. DISTRIBUTION OF BLANKETS & CLOTHS TO DESTITUTE WOMEN: We identified destitute women working as rag pickers and begging on streets. We have distributed blankets and cloths to 150 destitute women in collaboration with Help India at Water Tank area, Ashok Nagar, Kurnool. Mr.V.Anjaneyulu, Director, SST; Ms.V.Malleswari, Presdient, SST; Mr.Akhil, President, Help India; Mr. Shanavaz, Local Community Leader and others participated in the program. We also sensitized them on health, hygiene and sanitation.
