We the undersigned, for the purpose of forming a corporation pursuant to the provisions of the New Association Law of Liberia, do hereby make, subscribe acknowledge and file with the minister of foreign affairs these articles to incorporation for approval by the Minister or designate, to witi-

ARTICLE ONE: NAME OF CORPORATION

The Corporation shall be known and called the Liberia Albino Society, Inc. and for all other purposes it shall simply be referred to as the corporation.

ARTICLE TWO: EXISTENCE

The existence of the corporation shall begin at the filing of these Articles of Incorporation at the offices of the Minister of Foreign Affairs and upon the Ministers or designate endorsement thereon. The corporation shall have perpetual existence and shall be dissolved in accordance with statute controlling the dissolution of corporations.

Article three: Right and Privileges

The Corporation, which is a not for profit corporation, shall have the rights and privilege to engage in;

- a) All activities within the frame work of the laws of Liberia to protect all albinos against all forms of discriminations and segregative practices in the Liberian Society;
- b) All activities to promote the welfare and well-being of albinos and to promote equal opportunities for albinos; and
- c) All activities which the laws of Liberia permit to have the objectives for which corporations of this nature are formed.

ARTICLE FOUR: HEAD OFFICES

The head offices of the Corporation shall be located in the city of Monrovia. The corporation shall establish sub-offices in the various counties as the need arises.

ARTICLE FIVE BOARD
