The corporation shall have perpetual duration.

111.

The corporation is organized pursuant to the provisions of the Georgia Nonprofit Corporation Code, for the purpose of providing resources, training and information to families with disabilities and the providing of funds and support for such other electrosynary institutions as may be determined by the corporation.

IV.
