# THE SOCIETIES ACT

### THE SECRETARY ReachAll DISTRICT

Dear Sir/Madam,

I forward herewith a Certificate of Registration for your Society.

I take this opportunity of drawing your attention to the salient requirements of the Act and the Rules;

#### These are:

- (1) To keep one or more books of account showing details of all moneys received and payments made by the Society (Rules 3).
- (2) To keep a registrar of members showing the full name and address of each member the date on which each member was admitted to membership and the date on which each member terminated such membership (Rule 4).
- (3) To submit to the Registrar of your district, that is National Registration Officer, an annual return in duplicate on Form SO9 not later than the 31<sup>st</sup> March of each year (Rule 16).
- (4) To give notice to the Registrar of your District, that is your National Registration Officer, in duplicate on Form SO8 within fourteen days, of any change of office bearer (Rule 15).
- (5) To notify the Registrar of your District, that is your National Registration Officer, in duplicate on Form SO7 within one month, of any change in a Society's name or of any of the provisions of its constitution or rules or of any addition or decrease on its objects, or if it becomes a branch of or affiliated to or connected with any organization or group of a political nature established outside the country (section 15).
- (6) To notify the Registrar of your district, that is your National Registration Officer, in duplicate on Form SO7 of any change of a society's postal address of or the situation of its registered office (section 32).
- (7) To supply any of the information the Registrar may require under section 17 or 18 or Rule 19.

Forms S07, 8 and 9 can be obtained from the District of Provincial National Registration Office in which society's offices are situated.
