Seen the decree N° 2839 dated November 9, 2009;

Seen the law of the associations issued on Aug. 3, 1909 and in particular article six thereof:

Seen the circular N° 10/AM/2006 dated May 19, 2006 and its amendment N° 15/AM/2008 dated Sept. 12, 2008;

Seen the notification presented to the Ministry of Interior and Municipalities by the founders of the association named: "My School Pulse Association" and registered before the Common Administrative Department under N° 7450 dated May 7, 2010; Seen the suggestion of the director general of political and refugees' affairs by proxy;

Decides the following

Article one: The Ministry of Interior and Municipalities takes notice in the establishment of the association named:

"My School Pulse Association"

Its Headoffice: Naccache, New Naccache, area 2, Street 2, Nassif building -District of Metn.

Its object:

To help sick and needy children in general in order to pursue their studies and their education attainment and to insure them the entrainment and amusement as well as to help them to maintain normal and healthy lifestyle and to be engaged in the community.

Provided the abovementioned clauses shall be applied according to the laws and regulations in effect and after the agreement of the competent authorities.

Article Two:

The Constitutive Committee shall complete the procedures of the establishment of the association and convoke to the election of the administrative committee during a term of one year as of the date of publishing the memo in the official gazette.

Article Three:

The abovementioned company shall present to the Ministry of Interior and Municipalities in the first month of every year a list including the names of its members and a copy of its annual balance and its previous fixed account; otherwise it shall be subject to the application of the provisions of the law published in the decree N° 10830 dated Oct. 9, 1962 and its amendments.

Article Four: This memo shall be notified whenever required.
