Having explored in trajectory the devastating effects of poverty in Nigeria, especially in regions where majority are living in less than \$ 0.50 Cent Dollar per day. We contribute through research & development (RD), Partnership Humanitarian Investment Projects (PHI), we also contribute through spreading access to education and engaging science and technology agencies such as (NASENI) as well as participating with Microfinance institutes/banks in micro/agro credit loans for the Base of Pyramid (BoP).

OUR PROGRAMS:

Our Programme has been uniquely designed to assist and rescue communities from neglect, health, environment, economy, financial deprivation, and social injustice into transition to sustaining environment. Our method of assistance is to contribute first-hand direct/indirect support. However we work in realistic achievable goals by identifying a project which combines our interests to strengthen and improve the underserved communities. This informs the IIMGC Chart Action Plan (ICAP) such that it brings about maximum impact as well as maximum sustainability effect.

PROJECTS:

Selected target communities are all locations where immediate interventions are highly needed in the six geopolitical zones, Nigeria. All IIMGC Project(s) are strategically planned under the Global Impact Africa Framework (GIAF) and Humanitarian and Socio-economic & Health Empowerment Schemes (HUMSOHES) with the help of its professional consultants and Coalition partners known as SEEDS.

RATIONALE:

GIAF initiative is a framework for international co-operation and development on joint action for global solidarity, consultancy and intervention among local communities involving global leaders, global religious leaders, foreign and local authorities, local and foreign investors as well as sponsors in different countries that share common goals with the IIMGC and UN-SDGs goals and objectives. To join efforts in addressing major causes of economic and health issues in Nigeria, Africa and the world over.

STATEMENTS:

Due to an urgent need to resuscitate and recognize critical areas of highly needed interventions that will promote renewable energy, promote health, human rights, environment, education, food security, peace building, promote human development which sadly Nigeria; according to the results of the report of the United Nations Development Program (UNDP) has released in 2015 report on global human development and Nigeria's performance remains obstinately stagnant. As the current country's economic activities continues to weaken according to Thisday Newspaper article of May 23, 2016 edition " the nation's economy performed woefully as well, as unemployment rate rose to 12.1 per

cent in Q1 2016 from 10.4 per cent in Q4 2015. Underemployment also increased to 19.1 per cent from 18.7 per cent in the last quarter of 2015. The poor job numbers were on the back of 1.9 per cent expansion in the country's labour force as well as 340,000 net reduction in the number of persons in full-time employment. This could be attributed to the inherent weaknesses in the Nigerian economy which is clearly having a toll on businesses and the nation's ability to create jobs for its teeming young population," the NBS said". Which signifies an urgent need to boost economy as well as diversify wealth locally in the grassroots in a constant multiplication of growths and success. Although this era of economic hardship/crisis, as explained and felt by the general public, can be turned into an avenue to encourage Nigerians to join efforts, by supporting the government initiatives, enhance citizen sectors, strengthen participation in decision making, mainstreaming gender participation into projects and programs maintain peace, law & order and engage in socio-economic participations for a practical achievable goals. By partnering with other international and local partners, local and international Consulting firms, MDAs, Embassies, High Commissions, CBOs, CSOs, NGOs, faith based associations, and communities in other to form a formidable team to solve this most critical problems. We further enhance our focus in specific humanitarian expertise and networks to contribute to the quality and coherence of initiatives in a number of focus sectors with the overall aim to improve the effectiveness of our humanitarian development schemes.

6. Provide high level information to buttress knowledge sharing etc.
7. Provide international connection and knowledge sharing with Local Government and Community
8. Provide with information and assistance for sourcing for financial aids or grants.
9. Provide with investors from Brazil and Latin America/USA/Asia/ EU seeking to invest in Nigeria as well as provide willing partners interested to partner with local Nigerian contents for sustainable development schemes and in areas of oil & gas, real estate, departmental stores/malls, Micro-finance Banks, Mining/Agriculture etc.

Research and study of ecosystem degradation for the underserved poor who are the most vulnerable to ecosystem changes which leaves them exposed to natural and human disasters such as drought, famine and floods, oil spill; which threatens the aquatic and human habitats. This vulnerability is exacerbated by the fact that the poor also frequently live in areas that are already degraded or threatened, of low productivity (e.g. dry lands), high vulnerability, lake chad crisis (e.g. flood prone areas and some coastal zones), and lack the institutional and financial buffers that could help them manage stresses and shocks. These increasing pressures have heightened the risk of civil unrest, conflict, displacement and migration
11. Capitalize on the South-South Cooperation agenda to boost IIMGC organizational goals. (South-South cooperation is a broad framework for collaboration among countries of the South in the political, economic, social, cultural, environmental and technical domains. Involving two or more developing countries, it can take place on a bilateral, regional, sub-regional or interregional basis. Developing countries share knowledge, skills, expertise and resources to meet their development goals through concerted efforts. Recent developments in South-South

cooperation have taken the form of increased volume of South-South trade, South-South flows of foreign direct investment, movements towards regional integration, technology transfers, sharing of solutions and experts, and other forms of exchanges. Collaboration in which traditional donor countries and multilateral organizations facilitate South-South initiatives through the provision of funding, training, and management and technological systems as well as other forms of support is referred to as triangular cooperation).
