The Association is required to furnish the return even when the particulars are fall. The Bank Account mentioned in your application should exclusively be for receiving the foreign contribution and no other amount should be credited to this account. Any change with regard to the name of the Association, its address, registration aim and objects etc. should be promptly intimated to the undersigned and in case of the above changes, fresh registration of the Association under the provisions of the Act will be necessary.
