The corporation is organized for the following purpose or purposes:  This corporation is a nonprofit public benefit corporation and is not organized		

This corporation is a nonprofit public benefit corporation and is not organized for the gain of any person. Its purposes are exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, and shall

include providing human, health and social relief efforts to the underprivileged and marginalized victims of the former British colony of the Southern Cameroons (Amazonia). The organization will take care of displaced victims of violence; provide medical services, nutrition and housing to the poor and the displaced; and resettle abandoned and orphaned children. The organization will also advocate for the rights of the indigenous people, and monitor human rights conditions.

#### **Supplemental Provisions / Information**

Upon the termination, dissolution or final liquidation of the Corporation in any manner and for any reason, the Board of Directors shall first pay or provide for the payment of all liabilities of the Corporation; all remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code (or the corresponding section of any future federal tax code), or shall be distributed to the federal government, or to state or local government, for a public purpose.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to [your 501(c)(3) exempt purpose(s)] and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
