- 6) The blind people patients and the people who under go imprisonment due to corruption charges by the Government are not eligible to become as members in the Society.

- 1) Those who agree with the aims and objectives of the society and to work for the development of the Society can join in the Society without any age limit and the below donations as to become as members in the society., as to pay to become life members.

- 2) Life Numbers are members for life long in the Society.

- 3) Life members can participate and utilise their voting right in the General Body Meeting.
- 4) As a special invitees only life members can participate in the Executive Body and give they suggestions.

III. FUNCTIONS OF THE GENERAL BODY:

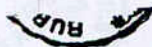
- 1) Those who pay the fee within the time and life members are called General Body.

- 3) General Body got right to join or regret the New Members.
- 4) General Body got right to accept the resignation of Executive Body and remove them.

- 6) Decide and except the Income & Expenditure and accounts of the coming year.

- 7) Appoint an Auditor to verify the Income and Expenditure of the society.
- 8) The Executive Committee will decide the New Programmes to be implemented.
- 9) Generally every year the General Body Meeting will be held, month compulsory and elect the new executive committee.
- 10) If 1/3 members give the written requisition to conduct the members President has arrange the General Body meeting within fifteen days.

IV. EXECUTIVE COMMITTEE:

- 1) Totally Seven members will be Executive Committee in the society including one President, Vice-President, Secretary, Joint Secretary, Treasurer and other Two Executive Members.
- 2) The Executive Committee will be elected by the General Body in simple majority voting method.
- 3) General Body will elect the Executive Body to Secrete ballet or majority opening of the members or any other method.
- 4) The President's elections will be held at first under the, Presidentship of who have decided by the General Body.
- 5) The Elected President of the Executive Body will conduct the remaining the Executive members elections.

V. FUNCTIONS OF THE EXECUTIVE COMMITTEE:

- 1) Executive body has to conduct the meeting at least once in a month.
- 2) In emergency the Executive Body may meet more than once.
- 3) The Executive Committee can join the new members through majority opinion of the members.
- 4) With 3/5 majority amendments and changes in the Bye-laws excepted and submit the General Body.
- 5) To remove the un-warranted members and got right to remove them.
- 6) To prepare the deferent welfare programmes to be implemented according to Societies Aims and Objectives and place before the General Body.
- 7) To implement the programmes which are resolved ion the General Body.
- 8) The President got right the to appoint or remove the full time employees or part-time employees to work in the Society.
- 9) To work vigorously to increase the Financial Resources of the society.

- v. Secretary got responsibility and right to maintain the records of the Society and to make the Staff to work regularly.

4. JOINT-SECRETARY: (DEPUTY SECRETARY)

- i. The Deputy Secretary will be conduct the duties of Secretary in the absence and permission of the Secretary.
- ii. If Secretary applies live or resign Vice President can conduct the duties of the Secretary with the permission of Secretary.

5. TREASURERS:

- i. The Societies funds will be deposited through Treasurer either in Banks or in Post Offices and has to transact with the permission of the President. If cheque books is there both President and Secretary/Treasurer should there.
- ii. Treasurer got right to give receipts for the Donations. Membership fee and other amounts to the Society. To maintain the accounts of Income & Expenditure up to date and place before societies Auditors whenever they want. To prepare Annual Budget and place before General Body.

6. EXECUTIVE COMMITTEE MEMBERS:

- i. Executive Committee members will attend every executive meeting and utilise and vote.
- ii. They will conduct the duties given by the Executive Body.

7. REMOVAL OF EXECUTIVE COMMITTEE MEMBERS:

- i. If Executive Members can not attend or participate in the Meeting consecutively four times they will loose their posts. But he will have the General Body Members.
- ii. In Emergency General Body Meeting the General Body can remove any executive members whatever the Designation he may be can remove the Executive Committee member if it proves that is working against to the Rules of Objectives of the Society.

8. ELIGIBILITY TO BECOME EXECUTIVE COMMITTEE MEMBERS OF ELECTION:

- i. A member who payees membership fee regularly and in time is eligible to context in the Executive Body Elections.
- ii. The member can context any number of times in the Elections those he was already elected.
- iii. One member can not context for more than one post.
- iv. A member can be complete is tenure in that post though he get the retirement stage.
- v. Member should have the membership before three months of Elections.

9. QUORUM:

- i. If 1/3 members present in the meeting General Body Meeting can be held.
- ii. If 2/3 members present in the Executive Body the Executive Body will be conduct.
- iii. When there is no quorum the Executive Committee can conduct the meeting with 1/3 members.

10. POST-PONEMENT OF MEETING:

- i. Secretary can postpone the meeting if the members can bot attend the meeting. After 1/2 house the commencement of the meeting according to quorum and the postponement Resolution should be written registered.

11. THE LIMIT OF EXECUTIVE COMMITTEE MEMBERS:

- i. Once elected the members will be in their post till the completion of one year from the date of their sworn.
- ii. The resolutions passed by the Executive Committee after the ternuers will not hold good. But they will hold the post and responsible for the fixed and moving assets till the election of the new executive committee.

11. AMENDMENTS:

CHANGES WILL BE DONE AS PER THE SECTION 12 OF SOCIETY REGISTRATION ACT XXI OF 1860.

12. MOVABLE AND IMMOVABLE PROPERTIES:

- i. The Movable and Immovable properties required by the Society should be purchased in the name of the Society and should be treated as the property of the Society, any member or any member holding any post in the Society will not have any individual rights, over them.
- ii. The Movable and Immovable property should be kept under the control of the people decided by the Executive Committee and the particulars should be shown in the Society Book Instantaneously.

14. WINDING UP OF ASSOCIATION:

Due to any reason if the Association is to be winded then the remaining movable and immovable properties after the deduction of the Expenditure and Loans from the movable and immovable properties of the society, should be handed over to any other Society which is having the same aims.
