The Committee on Non-Governmental Organizations of the Department of Public Information (DPI) met on 20 November 2015 to consider new applications from non-governmental organizations (NGOs) for association with DPI. I am pleased to inform you that the Committee approved **Center for Public Health** for association with the Department, effective immediately.

This association constitutes a commitment on the part of your organization to disseminate information and raise public awareness about the purposes and activities of the United Nations and issues of global concern. Associated NGOs are expected to focus a portion of their publications and information activities on the work of the United Nations. You are encouraged to cooperate with the [United Nations Information Centres or Services](#) in your country or region, as well as with representatives of [other parts of the United Nations](#) in your areas of work and expertise. Please make every effort to share your activities with UN offices in your area and to attend UN programs and events whenever possible. [[Guidelines Item i - Association](#)]

To confirm your NGO's association with DPI, your NGO must create a profile in the Civil Society Network (CSO Net). [[Item ii - CSO Net](#)]

I would like to take this opportunity to inform you that as an associated NGO, you are entitled to receive six grounds passes each year to enter the United Nations Headquarters in New York. The head of your organization is entitled to one of those passes. Additionally, through the 2015 Newly Associated Information Form (attached), you may designate up to three regular representatives, and two youth representatives (between the ages of 18 and 32 years old). Please email the signed form to undpingo@un.org, or bring it in person to the DPI/NGO Resource Centre. Only typed forms will be accepted; no handwritten forms can be processed.

The UN grounds passes will give your representative(s) access to the United Nations Campus in New York, including all open meetings of the United Nations bodies, to which they can attend as observers. NGO Representatives are also invited to attend the NGO Thursday Briefings organized by NGO Relations, featuring United Nations officials, government officials and other experts from the civil society community.



Before the end of each year, we will send your organization information regarding the Annual Review, which will also be available on our website. In order to maintain your association with DPI, you must complete the Annual Review form by the deadline. **[Item v - Annual Review](#)**

NGOs associated with the United Nations Department of Public Information need to be mindful of the rules and guidelines established by the General Assembly on the use of the UN Emblem by external parties. Organizations associated with DPI are strongly advised to become familiarized with these guidelines, as well as the appropriate use of the UN name and acronym, flag and grounds passes. **[Item vi - Use of UN Emblem](#)**

NGO COMMITMENT WITH DPI GUIDELINES

- i. DPI Association** – Association of NGOs with DPI does not constitute their incorporation into the United Nations system, nor does it entitle associated organizations or their staff to any kind of privileges, immunities or special status. Your NGO may mention that the organization is “associated with DPI”. The guidelines mentioned in [item vi](#) contain more information on the use of the UN Emblem and UN Grounds passes. We encourage you to widely share this document within your organization. Your designated representatives will also be asked to sign this agreement when they retrieve their UN grounds passes.
- ii. CSO Net Profile** – Please visit the [CSO Net website](#) and click on the last option titled “Please Click Here to Add Your Organization” to create your profile. Please search the database to check if your organization already has an existing profile. If so, you can update that profile. If you are creating the profile for the first time, remember to indicate that your NGO is associated with DPI before you submit it.
- iii. Intended Plan of Action** – Please describe in no more than 250 words how you plan to put your association with DPI into practice, the communication platforms you intend to utilize and the expected outcome of your initiatives for the upcoming year. To help you plan for this, we are including the calendar of the UN International Days. Our hope is that your plan of action will reflect your association with our Department, allowing us to better support the work of your organization. Please note that this intended plan of action must be submitted along with your 2015 Newly Associated Information Form.
- iv. Social Media/Website** – We encourage your organization to visit our website regularly, and place a link to our site (<http://outreach.un.org/ngorelations>) on your organization’s site. We also encourage you to “Like” us on Facebook at [UNDPINGO](#), follow us on twitter [@undpingo](#) and use our hashtag #DPINGO in your social media posts to further share your work with us.
- v. Annual Review** – NGOs associated with DPI in 2015 are exempt from completing the 2015 Annual Review; however, we strongly recommend that your organization still makes a submission.
- vi. Use of the UN Emblem** – The use of the UN emblem is restricted by General Assembly resolution 92(i), adopted in 1946. This resolution states that in order to prevent the misuse of the UN seal and emblem, it cannot be used without the authorization of the Secretary-General. NGOs are not allowed to use the official UN emblem on their websites, stationary, business cards or other items. NGOs may, however, request authorization to use the modified UN emblem which requires written approval and authorization by the Office of Legal Affairs. Please refer to the attached guidelines for further details on the use of the UN emblem.
- vii. Other NGO responsibilities** – You are also expected to keep NGO Relations informed of any changes to your organizational structure or bylaws by sending us a copy of the amended documents. In addition, you should also inform us of all changes in the name of your organization or contact information (mailing and email

addresses) as well as any changes of NGO representatives. If you have any further questions please contact: undpingo@un.org.
