GENESIS

GOAL

MANAGEMENT AND GOVERNANCE

Sita Gramoudyog Vikas Sansthan is governed by a rich constitution of the organization. As per the constitution of the society, there is a General Body and a Governing Board/Managing Committee. The General Body is the supreme body of the organization and has the highest authority for the entire functions & management of the organization.

The General Body takes the decisions pertaining to the plans of the organization, budget, audit & organizational policy matters. It elects the Governing Board/Managing Committee for specified period i.e. 5 years to look after the management and implementation of the program between the 2 Annual General Body Meetings. All above said decisions are taken in the Annual General Body Meeting.

Governing Board looks after day - to - day affairs of society. President, Secretary and Treasurer becomes office bearers of the Governing Board. All decision is taken democratically in the periodic meetings.

Decisions taken in Governing Board Meeting are communicated to staff during their monthly meeting. They are encouraged to bring ideas, suggestions and which are communicated to Governing Board through the Secretary of the organization. The Secretary is the Chief Executive Officer of the society.

SOCIO-ECONOMIC SITUATION IN OUR AREA

SGVS is intensively working in Arwal, Jehanabad, districts that form the south eastern Bihar. This area has a rich soil, normally a good monsoon rains and a conducive climate for agriculture.

But, the positive aspects end with that. On the dark side, there has been no worthwhile investment in agriculture for centuries; the uncertainty of the monsoon rains is increasing due to the climate change; there are unlimited fragmentations of the landholdings, irrigation facilities have miserably lagged behind, animal husbandry is practically extinct; there is near complete lack of industries and skill training to offer employment alternatives; the population has increased much beyond the producing capacity of land resources and, to top it all, the prevailing political and administrative system has become highly unresponsive, unproductive, inefficient and incorrigibly corrupt.

As the inescapable result, the agriculture here has become highly un-remunerative; there is wide scale unemployment and increasing impoverization leading to a deep frustration and dissatisfaction among the masses. Above all, this has very badly affected the social fabric of the rural areas and the agrarian relations have been strained to an irreparable limit.

Against all the above odds, we at SGVS, address a bevy of felt needs and put in our best efforts to meet rising expectations of a populace deeply disenchanted with the affectivity of the prevailing system.
